## **ANNUAL REPORT** 2016-2017

March of Dimes Canada Non-Profit Housing Corporation (NPHC), created in 1992, offers consumers with physical disabilities a single solution for support, personal care, and accessible, affordable accommodation. NPHC supports March of Dimes' vision of "creating an inclusive society", recognizing that people are happiest living in their own home.

Once again, the organization and especially its tenants, have been very fortunate in this past year to have so many generous supporters, many of whom have supported us for several years. Our engagement with donors in the local community has been the key to providing a quality home for our tenants. We acknowledge that we would not have been able to provide many critical improvements without this ongoing generosity of spirit and financial assistance.

For the past four years, NPHC has assisted in generating social and recreational funds for residents of each property. These are allocated for group activities such as day trips, pizza nights and movies; activities are facilitated by a staff liaison in each site. Donor funded activities are further supported by a manager from the MODC Fund Development Department.

Annual turnover remained relatively

low for all properties with 1 person moving out in each of the Hamilton, Toronto and Sudbury locations. Low turnover rates each year reflect the great stability of the March of Dimes' consumer population as compared to the tenant population-at-large. In Oakville 6 tenants moved out, several to long term care facilities and sadly a number passed away. The units were upgraded when vacant, and the plan is to continue to upgrade all units.

The Board of Directors and management sought to expand existing homes in Sarnia, Chatham and Sudbury. Sarnia's Standing **Oaks received Social Infrastructure** Funding (SIF) to add 4 additional bedrooms to the current 6, as well as to expand the living areas. This project began in this fiscal and will be completed by March 2018. Two proposals were made in partnership with a local builder in Chatham but were unsuccessful: staff will resubmit to future bids with lessons learned. The new Sudbury building that has been in the planning and fund raising stage for 3 years finally received adequate funding via the Social Infrastructure Fund program to move forward; this the result of a 300 page application submitted in March of 2017 to City of Sudbury. A capital campaign continues to ensure funds are available to create a new home for 12 individuals with brain injuries.

## STANDING OAKS

1212 Michigan Avenue, Sarnia

RESIDENT TYPE Single-family Home
CAPACITY 6 Bedrooms
YEAR BUILT 2003

This six-bedroom home was built in 2003 on Rotary Foundation land for which there is a 45 year ground lease with Concerned Citizens of the Medically Fragile, in partnership with NPHC. An accessible respite unit was included in the project and was in use 60% of the last year.

NPHC was a successful proponent in the 2015 Lambton County Request For Proposals for Investment in Affordable Housing funding, with a project approved in fiscal 2016-2017. In the summer of 2017, we are adding 4 additional consumer bedrooms and greatly enhancing the communal living space to the existing home. Special attention will be paid to the landscaping to ensure that the lot is more beautiful

than ever. Communications began with the neighbours to ensure that our standing as a good neighbour is maintained.

Standing Oaks is an example of the success that can be achieved by local engagement of March of Dimes and NPHC working with parents, local friends and the provincial government. NPHC is pleased to partner with the local Rotary Club and Community Concerns for Medically Fragile (CCMF) to ensure that the new project's design is as effective, functional and home like as the current home. Standing Oaks demonstrates what is possible with proper planning and commitment to create quality of life in a community setting for even the most medically fragile people.

## JEAN AND HOWARD CAINE APARTMENTS

259 Robinsons Street, Oakville

The largest facility owned and operated by NPHC is a 59-unit apartment building in Oakville, funded by the Ministry of Municipal Affairs and Housing in 1994-95, and maintained with operating funding from the Regional Municipality of Halton.

The building has one- and twobedroom apartments, and includes 24 apartments in which tenants receive round-the-clock scheduled and on-call attendant care services from March of Dimes Canada. The entire building has enhanced accessibility features and a mix of market and subsidized rental units.

Our tenants continue to enjoy the completely renovated activity room which Mattamy Homes and its wonderful team designed and built in 2015. The summer BBQ and the Thanksgiving and Holiday parties all ensure that the room gets joyful communal usage.

Our generous donors also contributed to the quality of life of our Oakville tenants. The May Court Club, Rotary Club, Walmley, Cadillac Fairview as well as the AWB, D.H. Gordon and Oakville Community Foundations provided significant financial assistance. An initiative led by

Barbara Caine enabled the agency to replace many faucets in the tenants' apartments. These gifts have enabled the corporation to continue to improve many of the tenant kitchens. Over the past 5 years, these charitable organizations have been generous and inspiring examples of the engagement of tenants with the local community.

The Air Make Up unit, an essential and costly infrastructure item impacting quality of life, was also replaced with generous funding from Halton Region. The domestic hot water tank liner was replaced at the same time. The sprinkler system pipes were replaced given they were at end of life and undergoing costly repairs.

The Property Liaison Committee, comprised of volunteers and tenants, met on a regular basis to review building issues and recommend opportunities for improvements to the property and its management.

The Halton Regional Housing authority provides the key financial support and is always available to advise and consult. We are proud to work in partnership with these experts in the community. The

funding includes Rent Geared to Income subsidy for tenants without which many could not enjoy the beautiful, accessible, well located Caine apartments and the supportive housing environment which our corporation and March of Dimes Canada provide.

Our long-time resident, Heather McKinnon, leads the work to maintain the gardens through each season. The gardens are simply stunning as a result of her tireless effort and eye for beauty.

The Christmas party was a wonderful event with the generous contribution from the parents and siblings of the late and beloved former tenant, Greg Gittings. The Gittings family again contributed to a Better Living Fund in memory of their son, and these funds provided support for parties and excursions.

The Adrock Capital Corporation also gave generously to the Better Living Fund and the Social funds of each property. These gifts are exceptional in enabling NPHC to be more than housing, and the tenants to have more than personal support care.

## JASON'S HOUSE

66 West 28th Street, Hamilton

**RESIDENT TYPE** Single-family Home **CAPACITY** 4 Bedrooms **YEAR BUILT** 1991

NPHC owns and operates a four-bedroom home in a single family residential neighbourhood in Hamilton. Named "Jason's House" in honour of its first tenant, it accommodates long-term residents who need a high level of assistance to optimize their independence.

The home continues to benefit from the active involvement and contributions of neighbours and volunteers. The bathroom received a needed renovation and brightening. The Jason's House Property Liaison Committee was very active and once again had great success in their fundraising endeavours. In early 2017, staff

submitted an application to add 2 bedrooms to the house and to enhance the existing living space and safety features. The decision is pending on that application.

For many years, the local Mount Hamilton Horticultural Society has supported the maintenance and improvement of the Jason's House gardens. This year was no exception; the beautiful garden contributed to the pleasure of tenants and neighbours alike. It is a perfect model of engagement with the community and inclusiveness in a lovely residential community.

## MEYNELL HOUSE

30 St. Lawrence Street, Toronto

**RESIDENT TYPE** 2-Storey Building **CAPACITY** 4 Bedrooms **YEAR BUILT** 1994-1995

NPHC operates under a head lease at this property. In 2016-2017, donations enabled us to provide much needed kitchen supplies for the use of the staff and consumers. An ongoing relationship with the Boys and Girls Club meant that at each holiday celebration, the consumers received very generous gift baskets. The holiday parties and BBQs were attended by consumers, family, friends and volunteers. To enhance the safety of all, wired smoke alarms were installed, reducing the amount of time taken to exit the building during an alarm.

Residents have very little disposable income and thus donations and the contributions of staff, volunteers and others, have made an immeasurable difference to the comfort and quality of life for the residents. Visiting the Toronto Zoo and attending a Blue Jays game were some of the highlights for tenants during the year. Ongoing donations from Adrock Capital have assisted with the quality of social life in the building as has the "hot meal fund" from the Meighen Foundation.

Dixon Neighbourhood Homes is the owner of the property, and they have been unfailingly helpful in addressing tenant needs; we value their partnership immensely.

## WADE HAMPTON HOUSE

2915 Bancroft Street, Sudbury

**RESIDENT TYPE** Single-family Home **CAPACITY** 9-bedrooms & 2 apartments **YEAR BUILT** 2011

Wade Hampton House has now been operating for five years; it is a nine bedroom congregate care home with two rental apartments. The property has been well-received by the tenants and their families; and the corporation has continued to make improvements as needed. Our eleven residents have developed a great sense of community as we have maintained 100% occupancy since the opening of this building.

In this fiscal, the hallway flooring was replaced to address buckling that occurred as a result of cracking in the old cement foundation.

New, very resilient and attractive sprayed flooring was used and is appreciated by staff and consumers.

In 2015, a capital campaign was launched with the goal of \$1 million to support the expansion of our services in Sudbury, by building another state of the art accessible building for 12 consumers on the same property. Our local architect, Chris Perry, completed the design package for the proposed new facility. At that time, March of Dimes Canada provided funding to have a full time Campaign Coordinator who successfully recruited a campaign cabinet consisting of: Chair: Renee Scott, Chair of Events Sub-Committee: Nancy West, Treasurer; Lori Lepage, Spokesperson; Candice Kirkbride, Directors; Rebecca Thibodeau-Perry, Nicholas Ryma, Wenting Zhou and Julie Wilson, supported by our contract campaign manager, Susan Levesque.

The Sudbury Credit Union, the Bishop Carter Foundation, numerous local donors as well as a generous anonymous donor through Gift Funds Canada provided very generous donations to the Capital campaign and to date we have raised \$300,000. In our last annual report, we stated that we submitted an application to the Ministry of Health to support the construction of the new building. In the ensuing period, the City of Sudbury issued a Request for Proposals for affordable housing under the Social Infrastructure Fund program. In March of 2017, staff submitted an application for a \$3M construction project; a grant of \$1.8M was subsequently approved. This project will be completed in the upcoming fiscal, resulting in a new home on the same property, and expected move in date of April 2018. Fundraising will continue to support this exciting initiative. We are grateful to our supporters, staff and volunteers who have worked tirelessly to bring this dream to its present stage.


