Ontario March of Dimes' Non-Profit Housing Corporation (NPHC) continued to operate four facilities in 2006-2007 – three owned and one leased. The owned facilities are Standing Oaks in Sarnia, Jason's House in Hamilton and the Jean and Howard Caine Apartments in Oakville; the leased facility is located at 30 St. Lawrence St. in Toronto.

These facilities continue to have high occupancy rates with low turnover. While we did not add any new units or facilities during the year, we did explore a couple of opportunities in Wasaga Beach and Sudbury, neither of which has yet to come to fruition.

We started the process of analyzing what a successful home for people with severe disabilities would require, both physically and financially. To that end volunteers and staff contributed to a project that outlines some of the design features that should be considered, and to cost these.

We considered a design-built home and developed a preliminary model for assessing financial viability for either purchasing or building a home. This has led to an overall visioning process for the Non-Profit Housing Corporation. The model is being refined and the assumptions will be tested in the coming year.

We have had few capital projects this past year, all minor in nature as most of our facilities are still relatively new and well maintained. While our capital reserve is growing, we are still working through a process of determining the overall long-term capital needs to ensure we have sufficient reserves to address major projects in the future such as a new elevator for Oakville. The only major project outstanding is the acquisition and installation of a back-up generator for the St. Lawrence Apartments in Toronto for which we continue to seek funds.

Standing Oaks (Sarnia) Highlights:

A garden was designed and donated by the Social Service class of Lambton College. It has beautiful perennials and a bubbling rock fountain;

Jason's House (Hamilton) Highlights:

- Jason's House will be included as part of Hamilton's Annual Garden Tour, to be held on July 15, 2007;
- The annual Jason's House Barbeque is being held on August 8, 2007 from 4 p.m. to 7 p.m.

Jean and Howard Caine Apartments (Oakville) Highlights:

- The Town of Oakville kindly placed a mailbox in front of our building after learning that it was difficult for tenants to travel to send and receive mail:
- Many tenants helped out when our superintendent was absent due to illness and the corporations thank them;
- Sincere thanks also to Jim Bilcox for looking after the gardens and helping to maintain the building;
- The tenants are enjoying a monthly newsletter, which is creatively produced by tenant Pamela Read from contributions received from tenants;
- Capital improvements have commenced in the building. Management will be implementing a program to improve the flooring in the units and renovating the washrooms as needed;
- A weekly Barbeque is scheduled to take place through the summer for all tenants to enjoy.

30 St. Lawrence Street (Toronto) Highlights:

- This facility is fully occupied;
- We are actively searching for funds to provide this property with a much-needed emergency generator;
- Tenants and staff enjoyed a wonderful Christmas gathering. Thank you to Patricia Peel, Chair of the Property Management Committee, for the wonderful gift donations;
- The Committee organized a community meet-and-greet Barbeque during the summer, which was well attended by the tenants, neighbours and the local police department.
