Ontario March of Dimes Non-Profit Housing Corporation (NPHC) continued to operate four facilities in 2007-2008 – three owned and one leased. The owned facilities are Standing Oaks in Sarnia, Jason's House in Hamilton and the Jean and Howard Caine Apartments in Oakville; the leased facility is located at 30 St. Lawrence St. in Toronto. All facilities have experienced low turnover rates.

The highlights for the year ending March 31, 2008 are the following; and all address and acknowledge the amazing volunteers, support organizations and partners.

Standing Oaks - Sarnia

- A new awning is being installed in the back patio to provide shelter on hot days for the tenants to sit under while enjoying the beautiful gardens planted last year.
- A blue spruce tree was planted in the front of the house which will further add to the character of the home in the years to come.
- A garden was planted just below the front window of the house. Many thanks to Community Concerns for the Medically Fragile (CCMF) for their continued support and efforts to make this facility a wonderful home to the tenants.
- The tenants are serviced by the superb staff at Standing Oaks who also beautifully maintain the home.

Jason's House - Hamilton

- Jason's House's back fence was beautifully painted to add further artistic flavor to the back yard that has already been landscaped for the tenants to enjoy.
